INSTRUCTIONS

General Notes:

1. This Entry Form is to be used by **Members** of the MKA only. A separate Overseas Entry Form is available for overseas exhibitors (where applicable).
2. Details of the Exhibit(s) & Exhibitor(s) must be as shown on the MKA Certificate of Pedigree. The Exhibitor must also be the registered owner of the Exhibit.
3. The transfer or application for transfer must be submitted together with the entry form if the Exhibit is not yet registered with the MKA or transferred to the Exhibitor's name.
4. The Exhibitor must **countersign all alterations and corrections** on the Entry Form.
5. Entry Forms that are incomplete or those with incorrect details will be rejected.
6. **THE HANDLER OF A DOG MUST BE A REGISTERED MKA MEMBER**
7. The exhibitors Pass must be collected by MKA MEMBERS only.

Entry Form Submission & Entry Fees:

1. Entry forms submitted without the appropriate entry fees will be rejected.

General Notices:3.

1. The MKA shall not be liable for any form of illness or disease that dogs may contract at a show. Exhibitors are required to take every reasonable precaution to prevent the introduction of diseased or ill animals to the Show.
2. The dog entered must not have been registered or recorded as having been owned by the Judge within the period of sixty (60) days immediately preceding the show, except that this shall not apply when a Judge is appointed in an emergency.
3. The dog must not be handled or boarded by the scheduled Judge of the breed within a period of sixty (60) days immediately preceding the show.
4. **With effects from 1st January 2007 a dog can attain the title of Malaysian Champion** if it won 3 Challenge Certificates under 3 different judges or 1 Challenge Certificate and 9 Reserve Challenge Certificates or 2 Challenge Certificates and 6 Reserve Challenge Certificates.
5. Dogs with cropped ears as permitted in their breed standard will be accepted for registration and showing provided that the operation was performed by a registered veterinary surgeon. A letter by the veterinary surgeon certifying the operation giving full details of the dog must be filed with the MKA.
6. **WITHDRAWAL OF EXHIBITS** - Dogs entered for the Show SHALL NOT be withdrawn without reasonable cause. Should a dog that qualifies to compete in a higher category wishes to be withdrawn, the exhibitor MUST APPLY to the Judge through the Show Manager for his/her decision for such withdrawal.
7. **LATE CHECK-IN** - All exhibits that report in after the official closing time for CHECK-IN as printed in the program/exhibitor's pass will be subject to a SURCHARGE of RM20.00 per dog, payable in cash at the check-in counter. However, such exhibits will not be accepted if judging has already commenced for the Class in which the Exhibit has been entered. The latest time permitted for late Check-In is **11.00am** on the day of the show irrespective whether judging of the Class entered has commenced or not.
8. **ALL DOGS WHICH QUALIFY FOR GROUPS & BEST IN SHOW SPECIALS** (i.e. Best Puppy, Junior, etc) must be presented for judging in the In Group and In Show Specials. Dogs which are eligible for such Specials can only be withdrawn with the written consent of the Show Manager or his/her representative. Failure to observe this ruling will result in awards won in previous Classes to be withdrawn.
9. **EXHIBITION OF IMPORTED & LOCAL BRED DOGS** - Imported dogs that have arrived in Malaysia for more than 6 months and have not yet obtained MKA registration numbers cannot be exhibited. All Malaysian bred dogs above 6 months old without MKA registration numbers cannot be exhibited.
10. **COLLECTING RINGS & SHOW RINGS** – Non-members of the MKA and members of the public are not permitted within the Collecting Rings & Show Rings at any time.
