1. **Original Export Pedigree issued by the Kennel Club of the country of origin.\*\***  
(The applicant must be the register owner of the dog in the country of origin.)
2. **Airwaybill**
3. **Import Permit**
4. **Quarantine Certificate (Only required for dogs imported from countries where quarantine is required.)**

The Original Export Pedigree must be submitted within 6 months from the original date of application, or the application will be rendered Null and Void. There shall be no refund of application fees.

\*\*In cases where the application for Original Export Pedigree has already been submitted with the country of origin, a photocopy of the Certified Pedigree OR any document(s) that indicating the name of the imported dog must be submitted with this application. Otherwise, the application will not be accepted.
