**APPLICATION FOR ADDITIONAL OF AFFIX  
 (KENNEL NAME) AS PREFIX/SUFFIX**

(Effective January 1<sup>st</sup> 2005)

**APPLICATION FEES: RM 25.00 (Member Only)**

**RULES GOVERNING THE REGISTRATION OF AN AFFIX (KENNEL NAME)**

1. Before the name of a registered dog can be changed by the addition of the new owner's Kennel Name, the transfer of ownership must be recorded.
2. Used of an Affix:
  - (a) May only be used as a Prefix, that is to say, as the first word in the name of dog where the Grantee of the Affix is the breeder of the dog.
  - (b) May only be used as a Suffix, that is to say, as the last word in the name of a dog (including, at the discretion of the Grantee, the use of the world 'OF', 'BY', or 'AT' immediately before such Suffix), where:
    - (i) The Grantee of the Affix imported the dog and the dog is registered within the jurisdiction for the first time.
    - (ii) In the case of the Grantee being the owner of the Stud Dog taking the "Pick of the Litter" and upon obtaining a written consent from the breeder of the litter.
    - (iii) The Grantee of the Affix is the breeder of both parents of the dog and the dog is the first transferred to such Grantee.
  - (c) Such usage as in the preceding paragraphs may only be allowed insofar as the name of the dog does not exceed 30 letters.
3. When an imported dog's name has been changed (by addition of Affix as Suffix) the old name, in brackets, must be given after the new name at any exhibitor for which the dog may be entered for a period of 12 months after the change of name has been effected.
